Federation to vote on change to bylaws regarding officers

At the Oct. 8 meeting of the Federation in Los Angeles, a committee was formed to draft a revised section of the bylaws of the FPCSC. This was done so that more members could run for the various elected positions.

A three-member committee — Dick Willing, former president of the Federation; Jim McGuigan, president of the Poway Stamp Club; and Bill O'Connor, current president of the Federation — was established.

The section of the bylaws, Article III, Section B, presently reads:

“Qualifications. The President-Elect and Vice-President must have served a full term as President of one of the member clubs and must be members of the board at the time of nomination. The Secretary and Treasurer may be

any member in good standing of any member club at the time of nomination.”

There is no mention in the bylaws of the president of our organization. The assumption was that all future presidents were to come from the ranks of the vice-president and president-elect. That will not happen this time.

The proposal of the committee is to change the above section to read as follows:

“Qualifications. The President, President-Elect, Vice-President, Secretary and Treasurer must be in good standing of any member club, have served a full term as members of the board of the Federation, President of their respective clubs, elected to a position in their respective clubs, or nominated by their respective club for any posi-

Block of inverted Jenny traded for Z Grill

Two major U.S. rarities, a plate block of the Inverted Jenny airmail stamp and the 1868 1-cent Z grill stamp, have been traded.

The new owner of the Inverted Jenny block is Don Sundman of Mystic Stamp Co., and the new owner of the Z Grill stamp is Bill Gross, who is reported to now have the only complete collection of 19th century U.S. stamps.

Sundman posted the following letter on the Mystic Web site at <http://www.mysticstamp.com/jenny.asp>:

"Hi, I'm Don Sundman, stamp collector and president of Mystic Stamp Company. Today I'd like to share some exciting news.

"As youths, many stamp collectors make trades to improve their collections. However, Mystic Stamp Company's recent trade — a one-to-one exchange of two of the world's greatest philatelic rarities — is a land-

mark in the history of stamp collecting.

"Mystic traded its 1868 1¢ Z Grill for the only 1918 24¢ Jenny Inverted Error Plate Block in existence. With a combined value of \$6 million, these stamps may be the most valuable objects in the world in terms of weight. To put it simply, the Jenny Invert Plate Block is America's greatest stamp rarity. Only one exists!

"Mystic acquired America's rarest postage stamp, the 1¢ Z Grill, at auction in October 1998. As President of Mystic, I paid a record price for this rarity — \$935,000. And that's because I thought the stamp was worth much more! Only two of these stamps exist ... and one is a permanent part of the New York Public Library's collection. While Mystic owned the 1¢ Z Grill it was featured at many important stamp shows, and the stamp-collecting public was given many chances to view this

national treasure.

"The plate block of 24¢ Jenny Invert Errors that Mystic traded the 1¢ Z Grill for recently made headlines around the world when it sold at auction for \$2,970,000. It too is a one-of-a-kind treasure. Unfortunately, stamp collectors haven't been allowed to see the stamp since Interphil '76. Now that Mystic owns the Jenny Invert Plate Block, we'll be exhibiting it at major stamp shows. And I hope that means you'll get the chance to America's greatest stamp rarity.

credit cards, to complete his U.S. collection.

Gross is a bond trader, the Virtual Stamp Club article said, and the Z Grill completed his 19th century U.S. collection.

Charles Shreve, president of Shreves Philatelic Galleries, said Gross will exhibit the Grill at the Smithsonian Institution in Washington next spring.

"This is an incredible, historic accomplishment. Not even the Smithsonian National Postal Museum in Washington has one of everything," said Shreve, who represented Gross first in his purchase of the plate block

and then in the trade with Sundman.

"This is the world's greatest trade," Sundman said.

"The Z Grill is so-named for the embossed grill patterns in the paper used in certain early U.S. postage stamps," explained Sundman.

In 1918, collector William Robey purchased a sheet of 100 of the first airmail issue, a 24-cent stamp showing the Curtiss JN4-H biplane, at the main Washington, DC, post office for \$24, and noticed that the airplane was upside down. The clerk said he hadn't noticed, because he didn't really know

what an airplane looked like, but he'd take them back and give Robey another sheet if he wanted.

Instead, Robey kept the sheet and a week later, sold it for \$15,000.
