

# SESCAL 2019 BOURSE CONTRACT

October 4 - 6, 2019

Ontario Convention Center  
2000 E. Convention Center Way, Ontario, CA 91764

In this contract, it is understood that:

“SESCAL” refers to “Stamp Exhibition of Southern California,” an event conducted under the auspices of the Federated Philatelic Clubs of Southern California;

“Conference Center” or “OCC” refer to SMG-Ontario Conference Center, located at 2000 E. Convention Way, Ontario, California;

“Dealer” refers to the dealer indicated at “Firm Name” below on page 3.

WE AGREE TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS:

DEALER agrees:

- 1) That the assignment of booth space is made in good faith, but that SESCAL reserves the right to change the floor plan as necessary: **Booth number(s) requested** \_\_\_\_\_ (please refer to the tentative floor plan attached as Exhibit A); **PLEASE NOTE:** SESCAL will endeavor to accommodate your request or a suitable alternative but that **all booth assignment requests are subject to approval by SESCAL;**
- 2) That the Bourse space assigned is non-assignable, will be used exclusively by the Dealer and will in no case be used by any other person or organization. Under no circumstances will it be permissible to sublet or allow any other dealer to operate from your booth;
- 3) To leave in place signs and other SESCAL or Convention Center property;
- 4) To maintain the assigned booth perimeters in accordance with the layout approved by the County of San Bernardino Fire Marshall;
- 5) To obtain any required sales tax, vendor or other licenses and to submit all required reports;
- 6) That SESCAL is merely providing the Bourse Space in question. SESCAL will in no way be responsible for, nor be party to, disputes or controversies regarding sales and/or representations made by the DEALER. Any conduct which SESCAL, in its discretion, considers as bringing discredit upon the exhibition will be grounds for eviction.
- 7) Not to bring any property or equipment to the bourse area, including the bourse lobby, prior to 12:00 pm on **October 3, 2019**, and agrees to leave the bourse area, including the bourse lobby, by 6:00 pm on **October 6, 2019**. DEALER further agrees to be set up by 10:00 am on **October 4** and to remain open for business during the show operating hours (Friday, Oct. 4, 10 am to 6 pm; Saturday, Oct. 5, 10 am to 6 pm; Sunday, Oct. 6, 10 am to 4 pm). If special arrangements are necessary, please contact the SESCAL Bourse Chair as soon as possible.

SESCAL agrees to provide security officers; but neither SESCAL, the Federated Philatelic Clubs of Southern California, the Convention Center, nor any of their volunteers, committees, departments, contractors or employees shall be liable to DEALER, its proprietors, principles, officers, agents, employees or invitees for any damages or loss by theft or otherwise or by misconduct of any spectator or customer.

Dealer shall indemnify, hold harmless and defend SESCAL and Convention Center, their directors, officers, agents, volunteers and employees for and from any and all losses, claims, liability, damage, action, judgment recovered from or asserted against them or other expense (including, without limitation, attorney fees and expense) arising out of or

relating to Dealer's use of OCC or from the conduct of Dealer's business or from any activity, work, or things which may be permitted or suffered by Dealer's use of OCC or from any breach or default in the performance of any obligation on Dealer's part to be performed under any provision of this Contract or arising from any negligence of Dealer or any of its proprietors, agents, contractors, employees or invitees, including but not limited to the use of patented, trademarked or copyrighted materials, equipment, devices, processes or dramatic rights furnished to or used by Dealer or other persons in connection with Dealer's use of OCC. Such indemnification shall not be effective to the extent that the damage or injury results from negligence of SESCOAL or OCC. Dealer hereby assumes all risk of damage to its property placed in OCC or injury to its proprietors, officers, directors, employee, agents, contractors, invitees or any attendees at SESCOAL or in or about OCC from any cause, and hereby waives all claims in respect thereof against SESCOAL or OCC, except to the extent such damage results directly from the negligence of SESCOAL or OCC.

Booth fees include one room for 3 nights (Oct. 3, 4 and 5) (the "Provided Room") at the Doubletree by Hilton Hotel, Ontario Airport, free self-parking for each night.
